**MINIMUM EXPERIENCE AND TRAINING:**

- A) Five (5) years experience in the operation, maintenance and repair of a diesel or combustion turbine generators and auxiliary equipment involving synchronizing generators and using automatic controls, including one (1) year at the skilled level; or
- B) Any equivalent combination of experience and training which provides the minimum knowledge, abilities and skills.

**NATURE OF WORK IN THIS CLASS:**

Leads and performs skilled work in the operation, maintenance and repair of diesel or combustion turbine generators and its associated auxiliary equipment in a diesel or combustion turbine generating power plant.

**MINIMUM KNOWLEDGE, ABILITIES AND SKILLS:**

Knowledge of the standard principles, methods, practices, techniques, tools and test equipment used in the operation, maintenance and repair of diesel or combustion turbine plant auxiliary equipment. Knowledge of controls and operating features of a diesel or combustion turbine power plant. Ability to lead the work of others. Ability to interpret and diagnose readings from indicators and instruments. Ability to prepare time and material cost estimates of work projects. Ability to determine malfunctions of equipment and take corrective action as needed. Ability to apply and enforce safe work practices on the job. Ability to work effectively with the public and employees. Ability to understand, follow and provide oral and written instructions. Ability to perform arduous physical tasks, including climbing, stooping, and lifting of tools and test equipment and working aloft in strained and awkward positions. Skill in the use and care of tools and equipment common to diesel or combustion turbine plant operation, maintenance and repair of diesel or combustion turbine generators and its associated auxiliary equipment.

**ILLUSTRATIVE EXAMPLES OF WORK** *(Any one position may not include all the duties listed, nor the examples cover all the duties which may be performed.)*

Leads and performs skilled work in the operation, maintenance and repair of diesel or combustion turbine generators and its associated auxiliary equipment. Observes, records and interprets readings

**of all indicators or instruments. Prepares time and material cost of work projects. Operates controls of diesel or combustion turbine driven generators both manually and automatically. Communicates with the Electric Power System Dispatcher and when required, maintains load conditions by adjusting load requirements or electrical switching. Performs operational maintenance on equipment as required and makes repairs during overhaul periods. Applies safe work practices on the job. Performs other related work as required.**

**HIGH SCHOOL DIPLOMA/ Skills Assessment Certificate – Pursuant to Public Law 26-87 (effective May 17, 2002) and as amended by P.L. 31-254** All new employment in the service of the government of Guam shall have, as a reasonable measure of job performance, the minimum requirement of a high school diploma or a successful completion of a General Education Development (GED) test or any equivalent of a general education high school program, from a recognized, accredited or certified vocational technical institution, in a specialized field required for the job. For entry level positions a formal nationally recognized foundational skills assessment shall be required for consideration for employment.

**PROHIBITION AGAINST SEX OFFENDERS: Pursuant to P.L. No. 28-98.** “No person convicted of a sex offense under the provisions of Chapter 25 of Title 9 GCA, or an offense as defined in Article 2 of Chapter 28, Title 9 GCA in Guam, or an offense in any jurisdiction which includes, at a minimum, all of the elements of said offenses, or who is listed on the Sex Offender Registry shall work in any agency or instrumentality of the Government of Guam”.

**EVALUATION METHOD:**

A written test maybe required. When a written test is not required, applicants will be rated on a scale between 70.00 and 100 percent on the basis of their training, education and experience in relation to the minimum requirements of the positions.

**INTERVIEWING PROCEDURE/INTERVIEW CONTACT:**

Applicants certified for interview based on GPA Eligibility List will receive a **Notification of Certification and Interview Schedule**, Form #HR-NOC-01 via USPS mailing to their last known address. All applicants must contact the Human Resources Division to confirm their scheduled date and time of interview. For rescheduling of interview applicants must contact the Human Resources Division 2 days prior to date of scheduled interview. Applicants are responsible to update personal contact information to the GPA Human Resources Division at [gpahr@gpagwa.com](mailto:gpahr@gpagwa.com) as necessary.

Interviews for all certified, eligible candidates, whether in-person, virtual, or telephonic, will be held by the General Manager or his designee(s). **Individuals with disabilities requiring special accommodations must submit their request to the GPA Human Resources Division at [gpahr@gpagwa.com](mailto:gpahr@gpagwa.com) or (671) 648-3130 no later than 2 business days prior to the scheduled interview date.** In accordance with Personnel Rules and Regulations Section 4.A.3.11, the General Manager, at his discretion, may schedule a selection interview immediately after the establishment of an eligibility list for the position. Applicants who are pending submission of supporting documents at the time the selection interview is scheduled will not be considered for certification purposes.

**DISABILITY PREFERENCE:**

Applicants wishing to claim Disability Preference should submit a Government of Guam Disability Certification form, certified by the Director of Public Health & Social Services.

**VETERANS PREFERENCE:**

Applicants claiming veteran preference are required to provide a copy of their DD-214 (Military discharge form, Member 4 copy). Those claiming Compensable Disability are required to provide a copy of a letter from the Veterans Administration.

**EDUCATION:**

Applicants claiming degrees or credit hours are required to submit official or verified copies of transcripts or high school diploma or GED certification.

**HOW AND WHERE TO APPLY:**

**DRUG TESTING:**

As approved by Board of Directors effective May 30, 1995, **all applicants tentatively selected for this position will be required to submit to urinalysis to screen for illegal drug use prior to appointment.**

**IMPORTANT INFORMATION:**

Public Law 99-603 (8 USC Section 1324A) requires the Government of Guam to verify the identity and work eligibility to all newly hired employees. All new employees shall be required to provide proof of identity and work eligibility to work in the United States. The Government of Guam is required to comply with this law on a non-discriminatory basis.

If you are hired to fill a position in the Government of Guam, you will be required to present valid documents that will establish your identity and work eligibility.
